Ltd., ABN 86 007 138 276, 12/53 Gateway Boulevard, Epping, Victoria, Australia, is a financial member of the Australian Seed Federation (ASF) and as such follows all guidelines set down by that association and meets all legislative regulations, including packaging, testing, and labelling requirements. Fairbank's is an accredited member of the ASF Code of Practice.

Fairbank's stores bulk seed in a dry-conditioned area, and when packed this seed is hermetically sealed in foil packets or steel cans for re-sellers, agents and growers. Plastic airtight pails and smaller containers are also used when it is generally known that rapid usage is to occur. If it is known that a grower will use the supplied seed immediately, has a clean storage facility of thier own, and wishes to economise on packaging, seed may be supplied in bulk bags for transfer to the grower's own containers.

Fairbank's has the capacity to resell seed purchased from other commercial companies. This seed is normally on-sold in that company's original container, unless an odd amount has been requested. In that case, a hermetically sealed foil container or air-tight plastic container is used, transferring all relevant information regarding germination and purity from the original to the new, either by printed or hand-written labels, unless specifically requested otherwise by the customer.


